May kindly see the property statement received online from Sri Sumit Premi, A.D.J. (FTC) Balrampur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2009-2011 (2009-10 & 2010-11) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2009-2011 (2009-10 & 2010-11) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2009-2011 (2009-10 & 2010-11), the Gross income from salary is Rs.6,34,114/- and total deductions/savings/investment against GIS, CPF, SBI Equity Fund and Income Tax is Rs.55,467/-. Thus, a sum of Rs.5,78,647/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2009-2011 (2009-10 & 2010-11). The balance of his savings bank account(s) is Rs.22,550/- at the end of the financial year 2010-11.

In this connection, it is submitted that the Officer has already submitted his property statement at the time of joining into U.P. Judicial Service, online agianst Case Id: P00049942021 (Old Case Id : 7162) and the same has been processed before Hon'ble Mr. Justice Ram Manohar Narayan Mishra, Administrative Judge, Balrampur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2009-2011 (2009-10 & 2010-11) in its next financial year i.e., 2011-12 upto March 2012. He has submitted movable and immovable property statements of the financial year 2009-2011 (2009-10 & 2010-11) vide online dated 19.01.2022. As such, there is delay in submitting the same for which the officer has stated that "reason for delay in submission of property statement - Due to Data collection & misinformation", mentioned in the remark column of movable property statement.

May, therefore, if approved, property statements for the financial year 2009-2011 (2009-10 & 2010-11) of Sri Sumit Premi, A.D.J. (FTC) Balrampur, be laid before Hon'ble Mr. Justice Ram Manohar Narayan Mishra, Administrative Judge, Balrampur Judgeship for His Lordship's kind perusal and orders?
