May kindly see the property statement received online from Sri Uday Veer Singh, Addl. District & Sessions Judge, Meerut, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.35,47,426/- and total deductions/savings/investment against GIS, GPF, PPF, Insurances, Sukanya Samriddhi Account, loan repayments and Income Tax is Rs.21,29,251/-. Thus, a sum of Rs.14,18,175/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20) and the balance of his savings bank account(s) is also decreased by Rs.1,18,729/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife, working as Research Assistant, KGMU, Lucknow, have annual income of Rs.8,49,593/- & Rs.11,06,598/- in financial year 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id : P00007292020 (Old Case Id : 1550) and the same has been processed before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 24.01.2022. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated in the remark column, that:

"My younger daughter Ms.Saanvi Singh presently aged about 7 years. After her birth at the age of two months only she was suffered by neonatal Jaundice. she was diagnosed ALAGILLE SYNDROME (Paucit of Bile Ducts). Alagille Syndrome is the rearrest disease of Liver.She is regularly followed and look after by specialized Pediatric- Gastroenterologist and also she is under regular observation and investigation of Pediatric-gastroentrologist Due to above rearrest disease of Liver she is continuosly faccing many problems like low appetite, poor physical growth, pruritus (Itching on all over the body) at any time specially sleeping time, due to itching she got disturbed in sleeping, my wife also got disturbed in night. Due to above compellig circumstances my wife can not care & look after her alone. I have no elder member in my family to help of my wife and care & medication of my younger daughter except me. under above compellig circumstances, & due to Pendemic of Corona in last two years I could not submit the property statements with in due time.So kindly condone the delay in submitting the property statements. I hereby most humbly tenders an unconditional apology for delay in submitting the property statements in due time and also undertakes that such delay will not occurs in future."

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Uday Veer Singh, Addl. District & Sessions Judge, Meerut, be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
