May kindly see the property statement online received from Sri Raj Bahadur Singh Maurya, Principal Judge, Family Court, Etah regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that in the matter relating to timely submission of property statement, Hon'ble Mr. Justice Ajit Kumar, the then Administrative Judge, Budaun has been pleased to pass the following order in offline mode on 30.03.2022:-

"Fifteen days time is afforded as a last opportunity to the concerned judicial officers, failing which appropriate action shall be taken against them in the matter. Place again on 18th April 22. Let the officers be informed accordingly with 24 hours from today."

In compliance of His Lordship's order, the officer has submitted his due property statement vide online dated 01.04.2022.

The offline file, in which the abovementioned order was passed is being also submitted simultaneously through offline mode to His Lordship.

Here, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.55,79,206/- (Gross income is Rs.54,29,206/- and matured amount of LIC of Rs.1,50,000/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.18,20,828/- this financial year from previous year's balance, total of which is Rs.38,83,193/-. Thus, a sum of Rs.16,96,013/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years. It is pertinent to mention here that his elder son is Judicial Officer.

In this connection it is submitted that officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Auraiya in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 vide online dated 01.04.2022. As such, there is delay in submitting the same from the part of the officer, for which officer has not given any reason of delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Raj Bahadur Singh Maurya, Principal Judge, Family Court, Etah be laid before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
