May kindly see the property statement received online from Sri Zeeshan Mehdi, Addl. Civil Judge (Junior Div.), Ghazipur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.15,15,211/- and total deductions/savings/investment against NPS, GIS, PPF, Loan repayments, PLI, Insurances, and Income Tax is Rs.3,93,467/- and the balance of his savings bank account(s) is also decreased by Rs.40,731/- in this financial year from previous year's balance. Thus, a sum of Rs.11,62,475/- (Rs.11,21,744/- from salary and Rs.40,731/- from SB accounts) was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2019-2021 (2019-20 & 2020-21).

It is also pertinent to mention here that the officer's mother having annual income of Rs. 2.5 lakhs per annum approx. through her Law Books publishing & selling business.

In this connection, it is submitted that the Officer has already submitted his property statement held upto at the time of joining i.e., of joining into U.P. Judicial Service, online against Case Id : P00005012021 (old case id: 2540) and the same has been processed before Hon'ble Mr. Justice Manoj Bajaj, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 14.04.2022. As such, there is delay in submitting the same for which the officer stated in his online reply dated 05.09.2023, that due to Corona Pandemic prevalent at that time and the officer, being new to the service, was mostly under training, the submission has been delayed for which, he tenders unconditional apology. He shall remain highly indebted for this.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Zeeshan Mehdi, Addl. Civil Judge (Junior Div.), Ghazipur, be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders?
