In the financial years 2011-13 (2011-12 & 2012-13), his gross income from salary and saving bank account interest is Rs.11,89,090/- (Rs.5,011/- from saving bank account interest) and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, NSC and PPF is Rs.3,30,833/-. The balance of Rs.82,454/- has increased from his saving bank A/c's against the balance of the previous year. In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2009-11 (2009-10 & 2010-11) online against case id: P00052992022 and same has been processed before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2011-13 (2011-12 & 2012-13) in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements for the financial years 2011-13 (2011-12 & 2012-13) vide online dated 18.01.2022. As such, there is delay in submitting the same. In this regard, officer verbatim: "The statement could not be submitted by me within time. I apologies for the same and assure that I will remain careful in future and submit the statements timely in future"
