May kindly see the property statement online received from Sri Yogesh Kumar-III, Additional District & Sessions Judge, Budaun regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2013-15 (2013-14 & 2014-15), his gross income from salary and saving bank account interest is Rs.16,88,509/- (Rs.31,653/- from saving bank account interest) and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, NSC and PPF is Rs.5,57,339/-. The balance of Rs.8,081/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,39,251/- (Rs.11,31,170/- from salary and Rs.8,081/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2013-15 (2013-14 & 2014-15).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2011-13 (2011-12 & 2012-13) online against case id: P00053002022 and same has been processed before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements for the financial years 2013-15 (2013-14 & 2014-15) vide online dated 18.01.2022. As such, there is delay in submitting the same. In this regard, officer verbatim: "The statement could not be submitted by me within time. I apologies for the same and assure that I will remain careful in future and submit the statements timely in future"

May, therefore, if approved, property statements for the financial years 2013-15 (2013-14 & 2014-15) of Sri Yogesh Kumar-III, Additional District & Sessions Judge, Budaun be laid before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun for His Lordship's kind perusal and orders?
