

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Sushil Kumar Shashi, Presiding Officer, Commercial Court, Ayodhya, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2017-2019 (2017-18 & 2018-19)**, the Gross income from salary is Rs.39,23,061/- and total deductions/savings/investment against GIS, PPF, NPS, Mutual Fund, SIP, Car and Home Loan Repayments including payments other than loan, Insurances and Income Tax is Rs.27,69,297/- and the balance of his savings bank account(s) is also increased by Rs.5,29,144/- in this financial year from previous year's balance, total of which is Rs.32,98,441. Thus, a sum of Rs.6,24,620/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2017-2019 (2017-18 & 2018-19).

It is pertinent to mention here that his wife have annual income of Rs.4,25,000/- from her own profession Freelance Journalist/Writer and Agriculture.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id : P00051612021 (Old Case Id : 7337) and the same has been processed before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ayodhya Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has firstly submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 16.01.2022. As such, there is delay in submitting the same from the part of officer, for which he has stated in his online reply dated 19.02.2024, that "*due to bonafide mistake and oversight caused by judicial and administrative workload, I couldnot submit my said property statement on time. It is also submitted that due to spread of Corona epidemic and furthrt lockdown, I couldnot procure my bank statement in time. I undertake not to repeat the same bonafide mistake in future. I also tender my unconditional apology for the same. My said bonafide mistake may kindly be condoned, for which I shall be ever grateful.*"

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Sri Sushil Kumar Shashi, Presiding Officer, Commercial Court, Ayodhya, be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ayodhya Judgeship for His Lordship's kind perusal and orders?
