May kindly see the property statement received online from Sri Kirti Kunal, Addl. District & Sessions Judge, Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2015-2017 (2015-16 & 2016-17), the Gross income from salary is Rs.21,10,666/- and total deductions/savings/investment against NPS, GIS, PPF, Insurences and Income Tax is Rs.9,48,865/- and the balance of his savings bank account(s) is also decreased by Rs.6,46,476/- in this financial year from previous year's balance. Thus, a sum of Rs.18,08,277/- (Rs.11,61,801/- from salary & Rs.6,46,476/- from SB account) was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2015-2017 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2013-2015 (2013-14 & 2014-15) online against Case Id: P00053282022 and the same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) vide online dated 25.01.2022. As such, there is delay in submitting the same for which the officer has stated that (in his verbatim) "The statement could not be submitted by me on time. I apologies for the same and assure that I will remain careful in future and submit the statements timely in future."

May, therefore, if approved, property statements for the financial year 2015-2017 (2015-16 & 2016-17) of Sri Kirti Kunal, Addl. District & Sessions Judge, Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
