

## **Registrar(J)(Budget)**

May kindly see the online property statement received from Sri Umesh Yadav, Additional Chief Judicial Magistrate, Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 ( financial year 2018-20) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2018-19 & 2019-20 (financial year 2018-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20 (financial year 2018-20), total Gross salary & other income are Rs.31,48,944/- and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF/NPS, GIS, Income Tax, Tuition Fees, SBI Life policy, car loan, PPF and the balance of his savings bank account(s) is enhanced for Rs.61,479/- this financial year from previous year's balance, total of which is Rs.11,42,923/-. Thus, a sum of Rs.20,06,021/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2016-18 which had already been seen online by Hon'ble Mr. Justice Pankaj Bhatia , the then Administrative Judge, Basti on e-service ID 1684.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 ( financial year 2018-20) in the next financial year i.e., 2020-21 upto March 2021. Officer has submitted the same on 22.01.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"It is humbly submitted that due to covid lock-down I was unable to access the receipts that were required to furnish the relevant information for filling the property statement I sincerely apologize for delay"* mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 ( financial year 2018-20) of Sri Umesh Yadav, Additional Chief Judicial Magistrate, Basti be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
