May kindly see the property statements online received from Sri Jeevak Kumar Singh, Civil Judge (Senior Div.) Auraiya regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2015-16 & 2016-17, Total income is Rs.15,94,891/- (Gross salary is Rs.10,94,891/- and Agricultural income of Rs.5,00,000/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, Insurance policies, NPS, PPF and the balance of his savings bank account(s) is enhanced for Rs.6,86,120/- this financial year from previous year's balance, total of which is Rs.10,92,904/-. Thus, a sum of Rs.5,01,987/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that balance of PNB a/c has been enhanced due to the reason that one plot at Alambagh, Lucknow was purchased on 21.02.2003 before joining of service by his father in his name and the said plot has been sold in June 2016. The Amount Rs.57,02,400/- credited to P.N.B. S/B Account number 188600010019798 and he has transfered an amount of Rs.55,00,000/- to S/B account of his Father on 18.04.2017. He has already shown the said plot in his Property statement of joining (mentioned in his reply dated 01.10.2023).

In this connection, it is submitted that officer has already submitted his property statement at the time of entering into Judicial Service online against Case Id: P00034932021 (Old Case Id : 5640) and the same has been processed before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March, 2018. He has submitted movable and immovable property statements for the financial years 2015-16 & 2016-17 firstly vide online dated 24.02.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"the delay occurs due to rush of work and paucity of time. The inconvenience cause is deeply regretted"*, mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2015-16 & 2016-17 of Sri Jeevak Kumar Singh, Civil Judge (Senior Div.) Auraiya be laid before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders?
