May kindly see the property statement online received from Sri Mumtaz Ali, A.D.J. (POCSO), Shamli at Kairana regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary is Rs.44,78,719/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF and Repayment of Education Loan are Rs.15,59,424/-. The balance of Rs.5,30,607/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.34,49,902/- (Rs.29,19,295/- from salary and Rs.5,30,607/- from saving Bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2016-18 offline, which had already been seen by Hon'ble Mr. Justice Sameer Jain, the then Administrative Judge, Shamli Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 07.02.2022. As such, there is delay in submitting the same. In this regard officer stated that : He is writing to apologize for the delay in the submission of the property-statement. It is regrettable that due to the unfortunate passing of his mother in September 2019 and his father in 2020, along-with the challenges posted by his transfer from Bijnor to Gorakhpur. The officer has not intentionally delayed sending the property-statement, and now apologizes for the delay. (detailed application in attachment dated 05.02.2022).
