May kindly see the property statement online received from Sri. Surya Prakash Singh, A.D.J. (FTC), Gonda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court forRegistrar(J)(Budget) kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2012-14 (2012-13 & 2013-14), Gross income from salary is Rs.22,51,599/- and total deductions/ repayment/ savings/ investment against Gis, Ppf, Nps, Income tax, Lic policy's and the balance of his savings bank account(s) is enhanced by Rs.79,016/- this financial year from previous year's balance, total of which is Rs.8,85,670/-. Thus, a sum of Rs.13,65,929/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2008-10 offline which had already been seen by Hon'ble Mr. Justice Sanjay Mishra, the then Administrative Judge, Varanasi and of the financial year 2010-12 online against case id-P00054302022 and same has been moved before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial year 2012-14 (2012-13 & 2013-14) vide online dated 28.02.2022. As such, there is delay in submitting the same. In this regard, officer has stated that due to father's heart bypass surgery, covid 19 pandemic and annual transfers he could not submit the property statement in due time. for which the officer is seeking apology.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Sri. Surya Prakash Singh, A.D.J. (FTC), Gonda be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda for His Lordship's kind perusal and orders?
