May kindly see the property statement submitted online received from Sri Alok Kumar Parasar, District & Sessions Judge, Lalitpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2012-14 (2012-13 & 2013-14), his Total income from salary and other sources is Rs. 27,99,195/- (Total Salary Rs. 26,81,135/-, Arrears of sumptuary allowance Rs. 1,18,060/- and S/B interest Rs.71560) and total deductions/savings/investments against GPF, GIS, Income Tax, PPF, Insurances, House Construction Loan and the balance of his Saving bank A/c is enhanced for Rs. 2,63,607/- this financial year from previous year's balance, total of which is Rs. 16,60,239/-. Thus a sum of Rs. 11,38,956/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2011-12 and seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Allahabad.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto 31st March 2015. He has submitted movable and immovable property statements for the financial years 2012-14 (2012-13 & 2013-14) firstly vide his application dated 04.03.2022. As such, there is delay in submitting the same from the part of the officer and he has stated that he was not able to submit the property statement within time due to annual transfer and rush of judicial work for which he is regretful.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Sri Alok Kumar Parasar, District & Sessions Judge, Lalitpur be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and order?
