May kindly see the property statement online received from Smt. Minakshi Sinha, Chief Judicial Magistrate, Firozabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-19(2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19(2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below-

(1) In the financial years 2017-19(2017-18 & 2018-19), Total Gross income from salary is Rs.18,09,450/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, Home loan, LIC policies, PPF and the balance of her savings bank account(s) is enhanced for Rs.72,602/- this financial year from previous year's balance, total of which is Rs.12,76,585/-. Thus, a sum of Rs.5,32,865/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband Mr Vivek Verma is Senior Manager Law in Punjab National Bank Allahabad his Annual Income Rs 10,00000/-Approx

In this connection, it is submitted that officer has already submitted her property statement upto financial years 2016-17 which had already been Seen by Hon'ble Mr. Justice Bachchoo Lal, Administrative Judge, Pratapgarh in the Misc. file of the officer .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19(2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial year 2017-19 vide online dated 05.03.2022. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2017-19(2017-18 & 2018-19) of Smt. Minakshi Sinha, Chief Judicial Magistrate, Firozabad be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
