May kindly see the property statement online received from Smt. Minakshi Sinha, Chief Judicial Magistrate, Firozabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-21(2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21(2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below-

(1) In the financial years 2019-21(2019-20 & 2020-21), Total income from salary and rent income is Rs.31,23,358/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, Home loan, LIC policies, Max life insurance , PPF and the balance of her savings bank account(s) is enhanced for Rs.10,16,021/- this financial year from previous year's balance, total of which is Rs.26,24,430/-. Thus, a sum of Rs.4,98,928/- was therefore available with her to meet out the household expenditure of her family consisting of four members in both the financial years.

It is pertinent to mention here that her husband Mr Vivek Verma is Senior Manager Law in Punjab National Bank Allahabad his Annual Income Rs 11,00,000/-Approx

In this connection, it is submitted that officer has already submitted her property statement upto financial years 2017-19 which had already been processed on case id noP00054542022 before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21(2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial years 2019-21(2019-20 & 2020-21) vide online dated 05.03.2022. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21(2019-20 & 2020-21) of Smt. Minakshi Sinha, Chief Judicial Magistrate, Firozabad be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
