May kindly see the property statement online received from Sri. Indra Prakash, Additional District & Sessions Judge, Bahraich regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Gross income from salary including Refund from LDA, NSC Matured, Arrear and Leave Encashment is Rs.57,59,322/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, LIC Policy's, SBI Life Policy, NSC, PLI, (SIP & FDR of 20 lacs each from MOD balance Break), total of which is Rs.68,43,512/- which is **Rs.10,84,190/- more than his income**. Apart from this balance of his savings bank account(s) is **decreased by Rs.17,83,749/-** this financial year from previous year's balance Thus, a sum of Rs.6,99,559/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 online against case id-P00054652022 and same has been moved before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Bahraich Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 05.03.2022. As such, there is delay in submitting the same. In this regard, Officer has stated that records of bank account are misplaced alongwith this father and mother health was not well. Also, Officer has aplogised for the delay caused.

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Indra Prakash, Additional District & Sessions Judge, Bahraich be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Bahraich for His Lordship's kind perusal and orders?
