It is pertinant mention here that officer husband (Advocate, High Court of Himanchal Pradesh, Shimla) having annual income Rs. 7,00,000/- (Approx).

In this connection, it is submitted that the Officer has already submitted her property statement at the time of Joining into U.P. Judicial Service online against case id-P00054822022 and same has been moved before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. She has submitted movable and immovable property statements of the financial year 2015-17 (2015-16 & 2016-17) vide online dated 11.03.2022. As such, there is delay in submitting the same.
