In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross income from salary is Rs. 42,82,317/- and total deductions/savings/ investment against GIS, Income Tax, PPF, Car loan EMI, Sukanya Samridhi, and the balance of his savings bank account(s) is also enhanced by Rs.17,34,230/- in this financial year from previous year's balance, total of which is Rs.30,86,830/-. Thus, a sum of Rs.11,95,487/- was therefore available with her to meet out the household expenditure of her family consisting three members in the both of the financial year.

It is pertinent mention here that officer husband (Advocate, High Court of Himanchal Pradesh, Shimla) having annual income Rs. 13,20,000/- (Approx).

In this connection, it is submitted that the Officer has already submitted her property statement of financial year 2015-17 (2015-16 & 2016-17) online against case id-P00054832022 and same has been moved before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj for His Lordship's kind perusal and orders...

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 11.03.2022. As such, there is delay in submitting the same. In this regard, officer stated that's unconditional apology for delay in filling property statement. The delay in filling property statement due to extreme illness and there after sad demise of her mother-in-law.
