May kindly see the property statement online received from Dr. (SMT.) Manu Kalia, Additional Principal Judge, Family Court, Maharajganj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs. 42,44,798/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF, Car loan EMI, Sukanya Samridhi, and the balance of his savings bank account(s) is also enhanced by Rs.5,69,272/- in this financial year from previous year's balance, total of which is Rs.29,89,143/-. Thus, a sum of Rs.12,55,655/- was therefore available with her to meet out the household expenditure of her family consisting three members in the both of the financial year.

It is pertinent mention here that officer husband (Advocate, High Court of Himanchal Pradesh, Shimla) having annual income Rs. 13,20,000/- (Approx).

In this connection, it is submitted that the Officer has already submitted her property statement of financial year 2017-19 (2017-18 & 2018-19) online against case id-P00054862022 and same has been moved before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj for His Lordship's kind perusal and orders...

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 11.03.2022. As such, there is no delay in submitting the property statement.
