May kindly see the property statement online received from Sri Kamlesh Kumar, Additional District & Sessions Judge, Hapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.43,47,736/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, SIP, LIC Policy, Home Loan EMI is Rs.25,28,705/-. Thus, a sum of Rs.18,19,031/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years. And the balance of his savings bank account(s) is also decreased for Rs.1,23,929/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2016-18 online against Case id-P00054912022 and same has been moved before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur for kind perusal & order.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 12.03.2022. As such, there is delay in submitting the same. In this regard officer has stated that he could not submit his property statement within stipulated period due to his son who was suffering from Wills Tumor and his wife who was suffering from Breast Cancer, for which he is apologized and such repetition will not happen in future.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Kamlesh Kumar, Additional District & Sessions Judge, Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur for Her Lordship's kind perusal and orders?
