May kindly see the property statement received online from Smt. Jyotsna Yadav, Addl. Chief Judicial Magistrate, Kannauj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.16,54,746/- and total deductions/ repayment/ savings/ investment against GIS, NPS, PPF, RD and Income Tax are Rs.8,33,414/- and the balance of her savings bank account is also increased by Rs.1,49,979/- in this financial year from previous year's balance, total of which is Rs.9,83,393/-. Thus, a sum of Rs.6,71,353/- was therefore available with her to meet out the household expenditure of her family consisting four members of the financial year 2017-2019 (2017-18 & 2018-19).

It is also pertinent to mention here that the Officer's husband is a Govt. Employee whose annual income is approx. Rs.9,50,000/- in the financial year 2017-2019 (2017-18 & 2018-19).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id: P00054982022 and the same has been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 31.03.2022. As such, there is delay in submitting the same. In this regard, the officer has stated in the attachment dated 11.03.2022, that <u>due to some</u> personal & family engagement, she could not submit the property statement in due time for that she deeply regretted.

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Smt. Jyotsna Yadav, Addl. Chief Judicial Magistrate, Kannauj, be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
