In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.29,03,659/- and total deductions/ repayment/ savings/ investment against GIS, NPS, PPF, RD, SIP, Loan Repayment and Income Tax are Rs.14,35,635/- and the balance of her savings bank account is also decreased by Rs.1,58,192/- in this financial year from previous year's balance. Thus, a sum of Rs.16,26,216/- (Rs.1468024/- from salary and Rs.1,58,192/- from SB Account) was therefore available with her to meet out the household expenditure of her family consisting four members of the financial year 2019-2021 (2019-20 & 2020-21).

It is also pertinent to mention here that the Officer's husband is a Govt. Employee whose annual income is approx. Rs.10,80,000 in the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held upto the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id: P00054992022 and the same has been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 31.03.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Smt. Jyotsna Yadav, Addl.
