May kindly see the property statement online received from Sri Anil Kumar-X, District & Sessions Judge, Mainpuri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19(2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19(2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19(2017-18 & 2018-19), Gross income from salary is Rs.46,64,231/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, LIC Policy's, PPF, Home Loan EMI, Mutual fund and the balance of his savings bank account(s) is enhanced by Rs.3,41,476/- this financial year from previous year's balance, total of which is Rs.25,99,291/-. Thus, a sum of Rs.20,64,940/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2008-09 to 2016-17 offline and same has been moved before Hon'ble Dr. Justice Yogendra Kumar Srivastava, Administrative Judge, Mainpuri Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19(2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19(2017-18 & 2018-19) vide online dated 25.03.22. As such, there is delay in submitting the same. In this regard officer has stated that due to some family problems he could not make timely submission of his property statement, for which he is seeking unconditional appologies from the Hon'ble Court, with the assurance that such practice shall never be repeated in future. It is, therefore, requested that the Hon'ble Court may kindly be pleased enough to accept his sincere apologies. He shall always be indebted to Hon'ble Court.

May, therefore, if approved, property statements for the financial years 2017-19(2017-18 & 2018-19) of Sri Anil Kumar-X, District & Sessions Judge, Mainpuri be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri for His Lordship's kind perusal and orders?
