In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Total income is Rs.13,92,898/- (from salary Rs.13,56,222 Interest from FD Rs.36,676) and total deductions/savings/investment against GIS, NPS, Income Tax, Mutual fund, car loan and the balance of his savings bank account is also enhanced by Rs.5832/- in this financial year from previous year's balance, total of which is Rs.6,61,187/-. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted his movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 24.03.2022. As such, there is no delay in submitting the same.
