May kindly see the property statement dated 24.03.2022 received online from Sri Anubhav Singh, Judicial Magistrate, Unnao regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-20 & 2020-21 (2019-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that in the matter relating to timely submission of property statement of property statement, Hon'ble Mr. Justice Prakash Padia, the then Administrative Judge, Unnao has been pleased to pass the following order in offline mode:-

" Mr. Anubhav Singh, Judicial Magistrate and Smt. Shikha Singh, Additional Civil Judge (Junior Division), Unnao is directed to submit their statement of movable and immovable property, positively by 31st March, 2022 as per the order dated 02.12.2021 passed by Hon'ble The Chief Justice and they are further directed to submit reasons for delay in submitting the statement of movable and immovable property."

In compliance of His Lordship's order, the officer has submitted his due property statement and reasons for delay in attachment, according to which these statements could not be sent earlier in this financial year due to burden of judicial work. Hence, it is therefore requested, kindly to accept his apologies for delay, if any, and place the same before the Hon'ble Court for information and kind consideration.

The offline file, in which the abovementioned order was passed is being also submitted simultaneously through offline mode to His Lordship.

Here, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21 (2019-21), total Gross income from salary is Rs.12,21,488/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, contribution in PM Cares, repayment of car loan, Insurance policies, SIP and enhancement of balance of her savings bank account(s) comes to Rs.15,15,640/-, which is more than of his salaried income during these financial years. Nothing appears to be available left with him to meet out the household expenditure of his family consisting himself only. However, he submitted that the savings and premium were made from his professional engagements and money received from grandparents and parents prior to date of joining service and also money received from my salary after 15th November 2019.

In this connection, it is submitted that officer has already submitted her property statements at the time of joining into Judicial Service and the same has been "Seen" by Hon'ble Mr. Justice Chandra Dhari Singh, the then Administrative Judge, Unnao in Case IDno. 2365 on 27.07.2021.

It is further submitted that as per policy/Court's Circular Letter, the property statement for the financial years 2019-20 & 2020-21 of the officer was due on 1st April 2021 to be submitted. He has submitted the same on 24.03.2022 by stating reasons for the delay.

May, therefore, if approved, property statements for the financial years 2019-20 & 2020-21 (2019-2021) of Sri Anubhav Singh, Judicial Magistrate, Unnao be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Unnao for His Lordship's kind perusal and further orders?
