May kindly see the property statement online received from Sri Jagannath, Chief Judicial Magistrate, Bahraich regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-14 & 2014-15 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-14 & 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2013-14 & 2014-15, Gross income from salary is Rs.14,96,437/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, PPF and the balance of his savings bank account(s) is enhanced for Rs.96,603/- this financial year from previous year's balance, total of which is Rs.5,22,539/-. Thus, a sum of Rs.9,73,898/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service and for the financial years 2009-10 & 2010- 11 & 2011-12 & 2012-13 which had been processed on Case ID no. P00055572022, P00055582022 and P00055602022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2013-14 & 2014-15 in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-14 & 2014-15 firstly vide online dated 24.03.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he has submitted the aforesaid statement with delay due to lost of details of some accounts, illness of his parents, death of his mother and not getting the details of accounts in time, for which he has apologized and also ensures he will submit further statements in time in future" mentioned in his attachment dated 24.03.2022.

May, therefore, if approved, property statements of the financial years 2013-14 & 2014-15 of Sri Jagannath, Chief Judicial Magistrate, Bahraich be laid before Hon'ble Mr. Justice Vivek Kumar Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders?
