May kindly see the property statement submitted online received from Sri Kanhaiya Ji, Civil Judge (Senior. Div.), Jhansi, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary and other sources (Gross salary is Rs. 17,85,612/- and Rental Income is Rs, 44,000/-) is Rs. 18,29,612/- (aprox) and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, is Rs. 5,15,726/- . Thus a sum of Rs. 13,13,886/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 3,51,752/- (approx) this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt Divya Chaudhary is Civil Judge (Senior division), Saharanpur and her gross annual is income Approx Rs. 1100000/-. His father's gross annual income from business and agricultural income is approx Rs. 600000/- and his brother is salaried employee of Bharti Airtel Pvt. Ltd. and gross annual income is approx. Rs.1800000/-

In this connection, it is submitted that the officer has already submitted his property statements online at the time of joining which is also processed online and laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Jhansi Judgeship on e-service case Id no. P00055832022

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 26.03.2022. As such, there is delay in submitting the same from the part of the officer and he has stated that it couldn't be submitted in time for which he apologies and requested to kindly place it before Hon'ble Court.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Kanhaiya Ji, Civil Judge (Senior. Div.), Jhansi, be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Jhansi, Judgeship for His Lordship's kind perusal and orders?
