In the financial years 2016-18 (2016-17 & 2017-18), Gross income from salary is Rs.26,11,717/- and total deductions/repayment/ savings/ investment against GIS, NPS, INCOME TAX, PPF and Repayment of Housing Loan are Rs.17,54,942/-. Thus, a sum of Rs.8,56,775/- was available with her to meet out the household expenditure of her family consisting of two members in both of the financial years. And the balance of her savings bank account(s) is reduced by Rs.6,58,178/- this financial year from previous year's balance.

It is pertinent to mention here that officer's Mother is Family Pensioner (Central Govt.)

In this connection, it is submitted that the Officer has already submitted her property statements upto the financial year 2014-16 offline and same has been seen by the Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 26.03.2022. As, there is delay in submitting the same from part of the officer. For which, officer has stated that due to her transfer, covid-19 acute infection, her mother's sickness and some other family reasons, she could not submit the property statement on time, for which she humbly apologizes.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Ms. Sweta Verma, Additional Principal Judge, Family Court, Bulandshahar be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar for His Lordship's kind perusal and orders?
