May kindly see the property statement submitted online dated 26.03.2022 received from Smt. Divya Chaudhary, Additional Chief Judicial Magistrate, Jhansi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-19 (financial years 2017-18 and 2018-19) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years years 2017-19 (financial years 2017-18 and 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years years 2017-19 (financial years 2017-18 and 2018-19) total income from Salary is Rs.18,33,523 and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, PPF is RS.5,17,778. Thus, a sum of Rs.13,15,745/- was therefore available with him to meet out the household expenditure of his family consisting two members for both the financial years. The balance of her S.B.A/c is also decreased for Rs.302183/- this financial years against the balance of previous year.

It is also pertinent to mention here that the husband of the officer is also in U.P. JUDicial Service.

In this connection, it is submitted that the officer has already submitted his property statements at the time of enrering into U.P. Judicial Service currently processed online & a separate note has been made on case-id no.Pooo55682022.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2017-19 in its next financial year i.e., 2019-20- upto 31 st March 2020. As such, there is delay in submitting the same from the part of the officer for which she has to state that she had submitted her Annual Property Statement to the Hon'ble High Court through the physical mode (before the e-services portal was started) when she was posted as Civil Judge (Junior Division) in district Saharanpur and the same had been sent back to her for some additional information/ modification, but the said letter received has got misplaced during her transfer from district Saharanpur to district Jhansi. She therefore apologise for the unintentional delay so caused in submitting her annual property statement to the Hon'ble High Court.

May, therefore, if approved, property statements of the financial years 2017-19 (financial years 2017-18 and 2018-19) of Smt. Divya Chaudhary, Additional Chief Judiial Magistrate, Jhansi be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
