May kindly see the property statements online received from Sri Surendra Kumar Rai, Additional District & Sessions Judge, Rampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2017-19 (2017-18 & 2018-19), Total income is Rs.32,73,570/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, Sukanya Samridhi Yojna, repayment of loan, mutual fund, PPF and the balance of his savings bank account(s) is also enhanced for Rs.4,95,380/- this financial year from previous year's balance, total of which is Rs.20,97,264/-. Thus, a sum of Rs.11,76,306/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2016-17 which had already been seen by Hon'ble Mr. Justice D.K. Upadhyaya, the then Administrative Judge, Bahraich in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide online dated 26.03.2022. As such, there is delay in submitting the same. In this regard, officer tenders his unconditioned apology for not having sent the property statement earlier as he had missed a number of informations to be filled in the property form in the course of his annual transfer and he also requested to condone the delay.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Surendra Kumar Rai, Additional District & Sessions Judge, Rampur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders?
