May kindly see the property statements online received from Sri Manjeet Singh Sheoran, Principal Judge, Family Court, Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total income from salary is Rs.44,08,051/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, Car loan, Medi- claim policy, NPS, FDR and the balance of his savings bank account(s) is enhanced for Rs.9,89,260/- this financial year from previous year's balance, total of which is Rs.33,93,636/-. Thus, a sum of Rs.10,14,415/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife's annual income from rent of flats are Rs.2,78,200/- and Rs.1,44,000/- in the financial years 2019-20 & 2020-21. Besides this, she also have income from bank interests of Rs.15,245/- & Rs.8,665/- and FDR interests of Rs.43,800/- & Rs.42,709/- in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto financial years 2018-19 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Meerut, in the misc. file of the officer with the warning issued to the "officer should be cautioned to be careful in future and not to commit such mistake."

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March, 2022. He has submitted movable and immovable property statements for the financial years 2019-20 & 2020-21 firstly vide offline dated 07.07.2021 and submitted online on 28.03.2022 after compliance of Hon'ble Court's order. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-20 & 2020-21 of Sri Manjeet Singh Sheoran, Principal Judge, Family Court, Gautambuddha Nagar be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar Judgeship for His Lordship's kind perusal and orders?
