

**Joint Registrar(Judicial)(Budget)**

May kindly see the property statements of the financial years 2018-2020 submitted online dated 28.03.2022 received from Smt. Anu Saxena, Additional District & Sessions Judge (POCSO), Banda, in compliance of order of Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Banda in the matter relating to timely submission of property statements, communicated to the officer.

In this connection, it is submitted that Smt. Anu Saxena, Additional District & Sessions Judge (POCSO), Banda has not submitted their movable and immovable property statements, in compliance of Hon'ble Court's letter no.14325/IV-h-16/Admin.A-IV dated 03.12.2021. In the matter, Hon'ble Administrative Judge, Banda has been pleased to pass an offline order dated 21.03.2022, which is as under:

"In pursuance to order dated 2.12.2021 passed by Hon'ble Chief Justice of this Court, whereby the Judicial Officers who have not submitted their property statement were directed to submit the same within a week, by a common letter/Endorsement No.14325/IV-h-16/Admin.A-IV dated 3.12.2021, the said order was communicated to the Judicial Officers of State of U.P. However, the office report shows that Smt. Anu Saxena, Additional District & Sessions Judge, POCSO, of Banda Judgeship has not submitted her property statement for the year 2018-20 or 2019-21.

From the above, it is evident that the officer has not obeyed the order passed by this Court.

As a last opportunity, the Presiding Officer is directed to submit her property statement for the year 2018-20 or 2019-21 as the case may be, by 28.3.2022, or else adverse inference would be taken and the same would be viewed seriously."

The order of the Court had been communicated to the officer concerned on vide offline Court's letter dated 28.03.2022 by Fax/E-mail as well as registered post.

In compliance of the Hon'ble Court's order, the officer concerned has submitted the movable and immovable property statements of the financial years 2018-2020 on 28.03.2022 itself i.e. within due time granted by Hon'ble the Administrative Judge, Banda vide order dated 21.03.2022 as mentioned above, but there are some shortcomings in the submitted statements such as the officer has not mentioned deductions against GIS, NPS, Income Tax, etc. in column no.8 and shown the balance of her SB a/cs as on 19.02.2020 instead of 31.03.2020.

It is also submitted that, from the perusal of misc. file of the officer, it also shows that officer has submitted her property statements till 2009-10 only, however as per Court's circular letter no.63/IV-h-16/Admin(A) dated 10.12.1998 and C.L.no.16/IV-h-16/Admin.A dated 13.05.2004, "the Judicial Officers are required to submit property statement at the time of entering the service and thereafter at the interval of two financial years i.e., in every third financial year." As such, the officer has also to submit the property statements for the financial years 2010-12, 2012-14, 2014-16 and 2016-18 apart from the latest property statement for the years 2018-2020.

May, therefore, if approved, the property statement of the financial years 2018-20 furnished by Smt. Anu Saxena, Additional District & Sessions Judge (POCSO), Banda, in compliance of His Lordship's order dated 21.03.2022, be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda for His Lordship's kind perusal and orders on the following proposals:-

(A) If approved by His Lordship, Officer may further be asked to submit the property statements of the financial years 2010-12, 2012-14, 2014-16 and 2016-18 also, alongwith the reasons for non submission of the same and also resubmit the property statements of the financial years 2018-20 after removing shortcomings.

'OR'

(B) His Lordship may like to pass any other order as may deem fit and proper.
