May kindly see the property statements received from Smt. Rekha Singh, Additional District and Sessions Judge, Maharajganj regarding submission of statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that in the matter relating to timely submission of property statement of property statement, Hon'ble Mr. Justice Vikas Kunwar Srivastav, the then Administrative Judge, Maharajganj has been pleased to pass the following order in offline mode:-

“Call Explanation.”

In compliance of His Lordship's order, the officer has submitted her due property statement and regretted for delay submission in offline letter dated 05.04.2022, according to which she has requested to kindly apologize for delay submission and this mistake will not repeat in future.

The offline file, in which the abovementioned order was passed is being also submitted simultaneously offline mode to His Lordship.

Here, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial years 2018-20, Total income is Rs.46,26,444/- (Gross income from salary is Rs.38,11,214/-, Agricultural income of Rs.40,800/-, House rent of Rs.2,08,000/- and income from interest & others of Rs.5,66,430/-) and total deductions/Savings/investments against NPS, GIS, IT, PPF, Home loan, LIC policies and the balance of her SB a/cs is enhanced for Rs.12,54,639/- this financial year from previous year's balance, total of which is Rs.32,93,688/-. Thus a sum of Rs.13,32,756/- was therefore available with her to meet out the household expenditure of her family consisting of four members in both the financial year

It is pertinent to mention that the husband of the officer, Sr. Vijay Kumar, is an RTO whose annual income is Rs.21,07,908/- (F.Y. 2018-19) and Rs.20,63,134/- (F.Y. 2019-20) and her son earns annual income of Rs.9,28,582/- & Rs.10,75,428/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted her property statements upto the financial year 2016-18 online which have already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Hathras online in caseID no. P00004822020 on e-service portal.

It is further submitted that as per policy/Court's Circular Letter, the property statement for the financial years 2018-19 & 2019-20 of the officer was due on 1st April 2020 to be submitted. She has submitted the same on 01.04.2022 and request for apology in her offline letter dated 05.04.2022.

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Smt. Rekha Singh, Additional District and Sessions Judge, Maharajganj be laid before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj Judgeship for His Lordship's kind perusal and orders ?
