In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), his total income from salary is Rs.18,46,399/- and total deductions/savings/investments against GIS, NPS, Income Tax, PPF, LIC, Mediclaim policy, repayment of loans (Home loan & car loan) and Mutual funds is Rs.16,26,220/-. Thus a sum of Rs. 2,20,179/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 27,030/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife's Gross income is Rs. 1,50,000/- per annum.

In this connection, it is submitted that the officer has already submitted his property statements held at the time of joining into the Judicial Service online against Case Id: P00007262020 (Old Case Id: 1546), which has already been seen by Hon'ble Mr. Justice Ashwani Kumar Mishra, the then Administrative Judge, Basti.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has firstly submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 31.03.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Atul Kumar Nayak, Civil Judge (Senior Div.), Balrampur be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Balrampur Judgeship for His Lordship's kind perusal and orders?
