May kindly see the property statement online received from Sushri Diksha Tripathi, Additional Civil Judge (Jr. Div.), Basti, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.12,14,620/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, Insurances, NPS, Mutual Fund, R.D. A/C's and the balance of her savings bank account(s) is also enhanced for Rs.1,14,389/- this financial year from previous year's balance, total of which is Rs.7,97,913/-. Thus, a sum of Rs.4,16,707/- was available with her to meet out the household expenditure of her in both of the financial years.

It is pertinent to mention here that Janardan Tripathi (Father) - Government Employee, Income - 2,02,000 per month, (Retired on 31.03.2021 Pension - 1,00,000 per month) and Sunita Tripathi (Mother) - self employed, Income 2,50,000 per annum.

In this connection, it is submitted that the Officer has already submitted her property statements at the time of joining online against old case id-3620 and same has been moved before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Basti.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 01.04.2022. As such, there is delay in submitting the same. For which she stated that she was new in service and then pandemic occurred, due to bonafide mistake she could not submit the same. She apologizes for her mistake and ensure that she will not repeat this mistake in future.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sushri Diksha Tripathi, Additional Civil Judge (Jr. Div.), Basti be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Basti for His Lordship's kind perusal and orders?
