

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Smt. Shweta Tripathi, Judicial Magistrate, Muzaffar Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2019-2021 (2019-20 & 2020-21)**, the Gross income from salary is Rs.10,42,265/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, loan repayments including down payments & PPF are Rs.8,08,868/-. Thus, a sum of Rs.2,33,397/- was therefore available with herself in the financial year 2019-2021 (18.02.2020-31.03.2020 & 2020-21).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining in U.P. Judicial Service online against Case Id : P00011222021 (Old Case Id : 3218) and the same has been seen by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Basti Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 06.04.2022. As such, there is some day delay in submitting the same from the part of officer, for which she has stated in remark column, that:

*"I humbly want to submit that since I was new in this service and then the pandemic occurred. Due to a bonafide mistake, I was unaware of the urgency of submitting of property statement. Hence I filled up the property statement with delay. I apologize with my folded hands for my mistake with the assurity to not commit the same in the future."*

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Smt. Shweta Tripathi, Judicial Magistrate, Muzaffar Nagar, be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffar Nagar Judgeship for His Lordship's kind perusal and orders?
