In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.12,22,787/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Donation, Car Loan EMI, PPF and the balance of her savings bank account(s) is enhanced by Rs.75,782/- this financial year from previous year's balance, total of which is Rs.4,48,176/-. Thus, a sum of Rs.7,74,611/- was available with her to meet out the household expenditure of her family consisting of five members in both of the financial years.

It is pertinent to mention here that her father is suspended government servant having montly income Rs.34,000/-.

In this connection, it is submitted that the Officer has already submitted her property statements of at the time of joining online against case id- P00007272021 and same has been moved before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Basti Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 05.04.22. As, there is slight delay in submitting the same. In this regard officer has stated that she was new in this service and then pandemic occured. So due to bonafied mistake she was unaware about the urgency of submitting of property statment. But she has filled up her earliar property statment (of at the time of joining) which is pending at present. she apologize with my folded hands for my mistake with the assurity to not commit the same in future.
