May kindly see the property statement online, in compliance of Hon'ble Court's offline order dated 13.04.2022, received from Sushri Bhawana Sharma, Additional Civil Judge (Jr. Div.), Hathras regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information, as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2019-20 (14.12.2019 to 31.03.2020) & 2020-21, Total Gross salary is Rs.13,22,700/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, PPF a/c and the balance of her SB a/cs is also enhanced for Rs.1,69,550/- in this financial year from previous year's balance, total of which is Rs.3,93,550/-. Thus, a sum of Rs.9,29,150/- was therefore available with her to meet out the household expenditure of her family consisting two members in 1 year and 3 months (about) of the financial years.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into Judicial Service which has already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Hathras in Case ID no.2163.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial years 2019-20 & 2020-21 firstly vide online dated 15.04.2022, in compliance of Hon'ble Court's offline order dated 13.04.2022. As such, there is delay in submitting the property statement of the aforesaid financial years from the part of the officer for which officer has not given any reason of delay.

May, therefore, if approved, property statements for the financial year 2019-20 & 2020-21 of Sushri Bhawana Sharma, Additional Civil Judge (Jr. Div.), Hathras be laid before Hon'ble Mr. Justice Narendra Kumar Johari, Administrative Judge, Hathras Judgeship for His Lordship's kind perusal and orders?
