May kindly see the property statement submitted online received from Sri Rajeev Singh, Special Judge (E.C. Act), Pilibhit regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), his Total income from salary and other sources (Gross salary Rs. 18,51,698/- and income from FDR Rs. 1,29,140/-) is Rs. 19,80,838/- and total deductions/savings/investments against usual deduction from salary, Car loan and Insurances is Rs. 6,71,192/-/-. Thus a sum of Rs. 13,09,646/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. The balance of his savings bank account(s) is also reduced for Rs. 2,03,611/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt. Archana is Additional Tax Consultant and her income is Rs. 3,47,790/- per annum and her mother's income from farming is Rs. 5,00,000/- annually.

In this connection, it is submitted that the officer has already submitted his property statements online at the time of entering i.e., of joining into U.P. Higher Judicial service which is also seen online by Hon'ble Mr. Justice Alok Singh, the then Administrative Judge, Pilibhit Judgeship on e-service old case Id no. 1341 but not digitally signed.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e. 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 03.04.2022. As such, there is some delay in submitting the same from the part of the officer for which he has stated that it could not be uploaded within time and it has not been done intensionally. He begs pardon and assures that the delay will not be occur in future.

May, therefore, if approved, property statements for the financial years 2019-21 2019-20 & 2020-21) of Sri Rajeev Singh, Special Judge (E.C. Act), Pilibhit be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
