May kindly see the property statement received online from Sushri Anujaya Krishna, Civil Judge (Junior Div.) Sultanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income is Rs.12,28,140/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Donation, Loan Repayment and Insurances are Rs.2,68,167/-. Thus, a sum of Rs.9,59,973/- was therefore available with her to meet out the household expenditure of her family consisting four members of the financial year 2019-2021 (14.11.2019-31.03.2020 & 2020-21) and the balance of her savings bank account is also decreased by Rs.2,62,043/- in this financial year from previous year's balance.

It is pertinent to mention here that her mother is an Associate Professor having monthly income of Rs.1,30,000/- and her father receives Rs.2,000/- per lecture as Teacher of General Studies at IAS coachings.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining in U.P. Judicial Service online against Case Id : P00010172020 (Old Case Id : 1930) and the same has been seen by Hon'ble Mr. Justice Vivek Agarwal, the then Administrative Judge, Sultanpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 14.04.2022. As such, there is some day delay in submitting the same from the part of the officer for which she has stated that *"I was under the mistaken impression that the next property statement from my end would be due in April 2022 since I had completed two years service only in December 2021. Any delay in filing the same was purely unintentional. It was a bona fide mistake and I sincerely apologize for any inadvertent omission on my part and seek your kind consideration"*, in the remark column.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sushri Anujaya Krishna, Civil Judge (Junior Div.) Sultanpur, be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
