Thus a sum of Rs.33,32,847/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that the wife of the officer earned Rs.1,50,000/- approx. annually from Boutique in Lucknow.

In this connection, it is submitted that the officer has already submitted his property statements offline upto the financial year 2016-18(2016-17 & 2017-18) which had already been processed online on case id no.P00056912022 before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Siddharthnagar.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 31.03.2022. As such, there is delay in submitting the same from the part of the officer for which Officer, through his offline letter dated 21.07.2022, sent in the matter of explanation regarding this, has submitted that he heartedly regretted for not submitting the same through e-service portal within due time. The said offline matter has also been submitted separately on an offline file.
