It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 31.03.2022. As such, there is no delay in submitting the same.
