May kindly see the online reply dated 09/07/2024 received from Smt. Shwetsa Chandra, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, in compliance of order of Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra, in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted her movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Agra through detailed office note dated 22/05/2024, on which His Lordship has been pleased to pass the following order dated 25/05/2024:

"The delay in submission of the property statement at the time of joining is required to be explained by the Officer."

The order of the Court had been communicated to the officer concerned on 28/05/2024.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated in her online reply dated 09/07/2024, that (in her verbatim):

"The applicant sincerely apologizes for the delay in submitting her property statement. The applicant would like to bring to the kind attention of the Hon'ble Court that while she joined the judicial service on 17/01/2017 there was a gap in her understanding of the service rules, which primarily contributed to the delay in filing the property statement. The applicant sincerely apologizes and assures the Hon'ble Court that such delays will not occur in the future. The applicant requests you to put the above report for kind perusal of Hon'ble Court."

In this connection it is submitted that the officer has also submitted the property statements for the financial year 2016-2018 & 2018-2020 against Case id: P00040642021 & P00022122021 respectively through eServicesJO portal on 16/12/2021. However, due to delayed submission and some missing informations, the aforesaid statements have been objected accordingly and the same will be placed before His Lordship after getting reply by the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statement held at the time of joining the U.P. Judicial Services just after joining into U.P. Judicial Service. Her joining date is 17/01/2017. She has firstly submitted the aforesaid statement online dated 02/03/2020. As such, there is delay in submitting the aforesaid statement from the part of the officer. In this regard, officer has given the reason for delay and compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Smt. Shwetsa Chandra, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
