May kindly see the property statement received online from Sushri Diksha Agarwal, Judicial Magistrate, Etawah regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively Etawah ely to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.12,22,782/- and total deductions/ repayment/ savings/ investment against GIS, NPS, PPF, Car Loan repayments including amount paid other than loan and Income Tax are Rs.6,73,288/-. Thus, a sum of Rs.5,49,494/- was therefore available with her to meet out the household expenditure of her family consisting of two members in the financial year 2019-2021 (2019-20 & 2020-21) and the balance of her savings bank account is also decreased by Rs.10,888/- in this financial year from previous year's balance.

It is pertinent to mention here that her mother have annual income of Rs.3,00,000/- from rent and bank interest & Rs.2,40,000/- from private job in the financial year 2020-21 (as mentioned by the officer).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into U.P. Judicial Service online against Case Id: P00010032021 (Old Case Id : 3090) and the same has been seen by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Basti Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 01.04.2022. As such, there is one day delay in submitting the same for which she has stated in the remark column of movable proforma, that *"I was new in this service and then pandemic occurred due to which I was unaware about the urgency of submitting property statement. Hence, I filled up the property statement with delay..I apologize with my folded hands for my mistake with the assurance to not commit the same in future."*

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sushri Diksha Agarwal, Judicial Magistrate, Etawah, be laid before Hon'ble Mr. Justice Shamim Ahmed, Administrative Judge, Etawah Judgeship for His Lordship's kind perusal and orders?
