May kindly see the online property statements received from Sri Diwakar Prasad Chaturvedi, Presiding Officer, Motor Accident Claims Tribunal, Pratapgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, Total income is Rs.35,24,494/- (Gross income from salary including arrears, allowances, encashment, agriculture & from interest of NSC etc. are Rs.35,04,494/- and matured amount of LIC policy is Rs.20,000/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, LIC policies, PPF a/c, Car loan and FDR are Rs.28,90,957/-. Thus, a sum of Rs.6,33,537/- was therefore available with him to meet out the household expenditure of his family consisting of seven members in both of the financial year. And the balance of his savings bank account(s) has also been reduced for Rs.9,38,302/- this financial year from previous year's balance.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2009-10, which has already been seen by Hon'ble Mr. Justice Rajiv Sharma, the then Administrative Judge, Raebareli, placed in the misc. file of the officer. And property statement of the financial years 2010-12 & 2012-14, detailed notes have been laid online before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders on eService ID P00057482022 & P00057512022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements for the financial years 2014-15 & 2015-16 firstly vide online dated 01.04.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that "due to loss of various concern records I could not submit the property statement of financial year 2014-16 for which I am Seeking unconditional apology from Hon'ble Court", mentioned in his reply dated 04.04.2024.

May, therefore, if approved, property statements for the financial year 2014-15 & 2015-16 of Sri Diwakar Prasad Chaturvedi, Presiding Officer, Motor Accident Claims Tribunal, Pratapgarh be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders?
