May kindly see the online property statements received from Sri Anil Kumar Seth, Special Secretary & Additional L.R. (Legislative), Govt. of U.P., Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income are Rs.42,17,984/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Home Loan, Car loan, LIC policies, PPF a/c, SIP, RD and the balance of his savings bank account(s) has also been enhanced for Rs.5,08,121/- this financial year from previous year's balance, total of which is Rs.30,06,203/-. Thus, a sum of Rs.12,11,781/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that her wife is earning member from April,2020 as she gets Rs.7,000/- as home rent from her property at Lucknow.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Bareilly, placed in the misc. file of the officer. And for the property statements of the financial years 2018-20, detailed office note have been laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders on eService ID 3239.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 14.04.2022. As such, there is no delay in submitting the property statement of the aforesaid financial years.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Sri Anil Kumar Seth, Special Secretary & Additional L.R. (Legislative), Govt. of U.P., Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
