May kindly see the property statement online received from Sri. Manoj Kumar Agarwal, Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20) , Total income is Rs.60,33,128/- (Gross income from salary is Rs.54,08,416/- and from other sources(Bank Interest, Reimbursement of Training, Arrears, Petrol, IT Refund, LIC Matured) is Rs.6,24,712/- total deductions/ repayment/ savings/ investment against GPF, GIS, LIC & HDFC Policy's, Income Tax. SBI Life Insurance Policy, Home Loan EMI and the balance of his savings bank account(s) is enhanced by Rs.19,18,466/- this financial year from previous year's balance, total of which is Rs.39,00,559/-. Thus, a sum of Rs.21,32,569/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2017-18 offline and same has been moved before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh Judgeship in the misc. file of the officer

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 05.04.2022. As such, there is delay in submitting the same. In this regard officer has stated that he was transferred from lalitpur to aligarh & he Joined on 14.04.2021. Due to pandemic of Covid-19 property details and statements from bank etc. could not be fetched in due time and also due to heavy administrative work assigned by District Judge, Lalitpur. It is submitted that aforesaid statements about property has already been submitted on 16.04.2021. Therefore, he remained under the impression that he have not to submit that statement on portal. He have not committed deliberate default in submitting aforesaid statements on portal but it occurred inadvertently due to confusion for which, he pray for the pardon of Hon'ble High Court.

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Manoj Kumar Agarwal, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders?
