(1) In the financial years 2018-19 & 2019-20, Total Gross salary is Rs.16,51,274/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, NPS, Income Tax, PPF, down payment against purchase of car and car loan are Rs.6,50,565/-. Thus, a sum of Rs.10,00,709/-/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years. And the balance of her savings bank account(s) has also been reduced for Rs.89,897/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is also a Judicial officer and having annual income of Rs.13,63,117/-.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 firstly vide online dated 02.04.2022. As such, there is delay in submitting the property statements from the part of the officer for which she has requested "to grant her pardon considering delay due to lack of knowledge and heavy judicial work. Consider it compassionately and generously. Please forgive her and she will take care in future. Thanks", mentioned in remark column & officer's reply.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Smt. Zeba Rauf, Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Moradabad be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
