May kindly see the online property statement received from Sri Manish Kumar-I, Additional District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.44,26,914/- (total income from salary & allowances is Rs.36,81,265/-, Capital Gain of Rs.2,35,649/- and Agricultural income of Rs.5,10,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, LIC, NPS, PPF, SBI Life, Health Insurance, Income Tax, Personal loans, SIP, Shares and investment in Crypto Currency are Rs.29,00,440/-. Thus, a sum of Rs.15,26,474/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.59,593/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is advocate having annual income of Rs.7,55,000/- and Rs.6,75,000/- in the financial years 2020-21 & 2021-22 respectively. She also earns Rs.1,58,050/- & Rs.3,15,000/- from Agriculture in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2018-20 which had already been seen by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Etah, on e-service ID no.965.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 06.04.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 of Sri Manish Kumar-I, Additional District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
