May kindly see the online reply dated 23/09/2024 received from Dr. Suresh Kumar, the then Additional District & Sessions Judge, Amroha, presently posted as A.D.J. (FTC), Bulandshahr, in compliance of order of Hon'ble Mr. Justice Om Prakash, Administrative Judge, Amroha Judgeship in the matter of property statements for the financial years 2019-21 (2019-20 & 2020-21), communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) online dated 02.04.2022 on eServicesJO portal, which was put up before Hon'ble the Administrative Judge, Amroha through detailed office note dated 06/06/2024, on which His Lordship has been pleased to pass the following order **dated 29/08/2024**:

"Office has reported that there is slight delay in submitting the property statement, for which Officer has not given any reason.

C.L. No. 16/IV-h-16/Admn(A) dated 13th May, 2004 (in continuation of Court's Circular Letter No. 63/IV-h/16/Admn-A Dated 10.12.1998) relates to submission of statements of movable and immovable property to be submitted by all the judicial officers. The Circular Letter provides "the judicial officers be now required to submit property statement at the time of entering the service and thereafter at the interval of two financial years i.e. in every third financial year." The Circular letter further imperatively requires all Judicial Officers posted in judgeship to ensure strict compliance of the above circular Letter of the Hon'ble Court in the matter. Submission of property statement is not a mere farce formality but is a predominant requirement of Government Servants Conduct Rules.

Let the officer explain the delay in filing the statements.

Office shall forthwith place the property statements of the officer after receipt of his explanation."

The order of the Court had been communicated to the officer concerned on 31/08/2024.

In compliance of the Hon'ble Court's order, the Office has submitted his explanation **dated** 23/09/2024, in which officer has stated that (verbatim):

"It is humble request that due to not available of Bank statements and other unavoidable circumstances I couldn't submit my property statement of F.Y. above-mentioned in time that there is slight delay in submitting the property statement, kindly forgive me."

May therefore, if approved, movable & immovable property statement for the financial years 2019-21 (2019-20 & 2020-21) along-with the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Dr. Suresh Kumar, A.D.J. (FTC), Bulandshahr, be laid before Hon'ble Mr. Justice J.J. Munir, Administrative Judge, Bulandshahr for His Lordship's kind perusal and orders?
